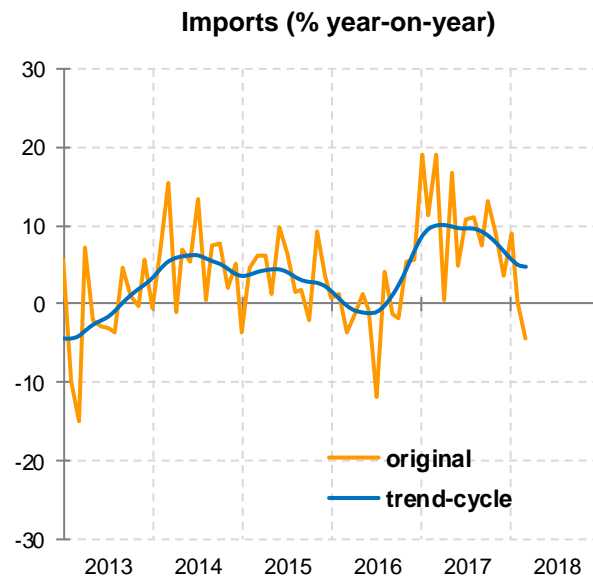
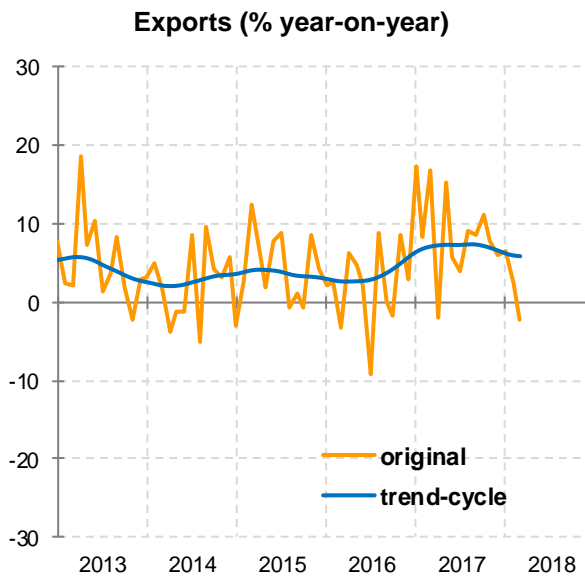
EXECUTIVE SUMMARY INTERNATIONAL TRADE REPORT

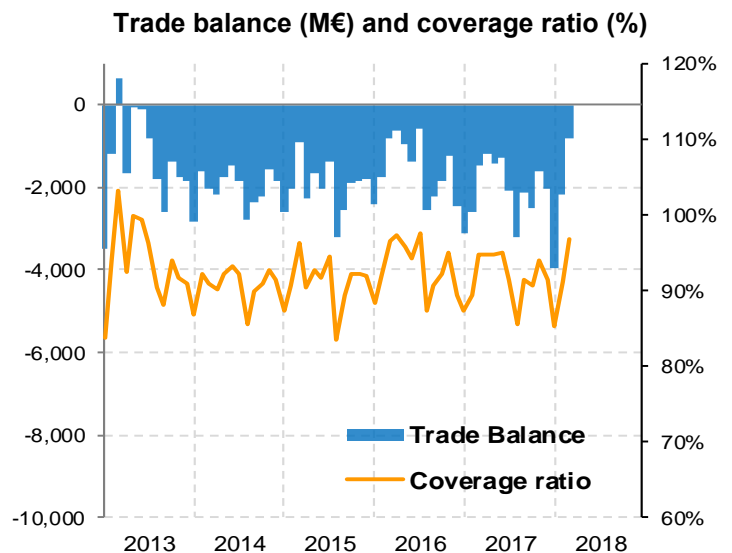

MARCH 2018

In March 2018, **Spain's exports diminished by 2.4%** year-on-year in nominal terms to 25,605.5 million euros, and **imports shrank by 4.5%** to 26,436.2 million euros. With seasonally adjusted data, both exports and imports augmented by 3.6% year-on-year. In **real terms**, exports fell by 4.8% year-on-year, as export prices advanced by 2.6%, and imports decreased by 4.9%, as import prices grew by 0.5%. In nominal terms on a **month-on-month** basis, exports went up by 13.4%, and imports by 6.8%. With seasonally adjusted data, exports increased by 2.1% month-on-month, while imports remained stable.

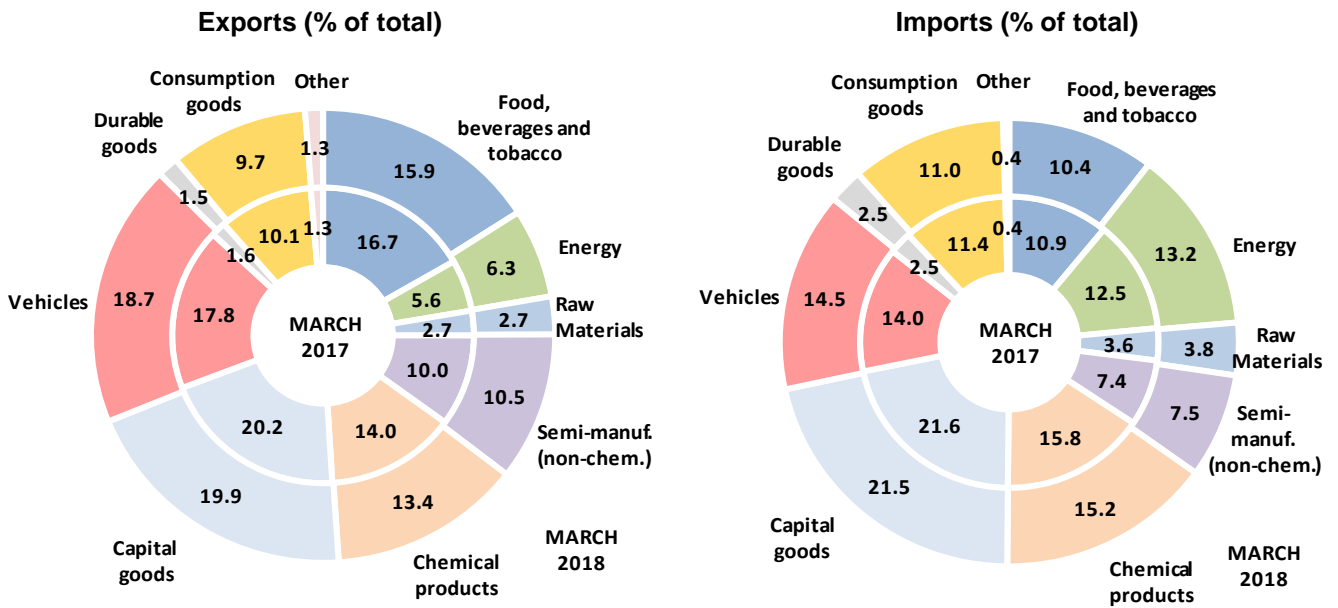


Spain's **trade balance** registered a deficit of 830.6 million euros, down from a deficit of 1,458.6 million euros in March 2017 (provisional data). The export/import **coverage ratio** reached 96.9, 2.1 percentage points higher than in the same month of 2017 (94.7% in March 2017 with provisional data). The **non-energy trade balance** reached a surplus of 1,029.2 million euros, from a surplus of 529.1 million in the same month of 2017. The **energy trade deficit** fell by 6.4% year-on-year to 1,859.8 million euros (compared to a deficit of 1,987.6 million euros in March 2017).



Sectoral data

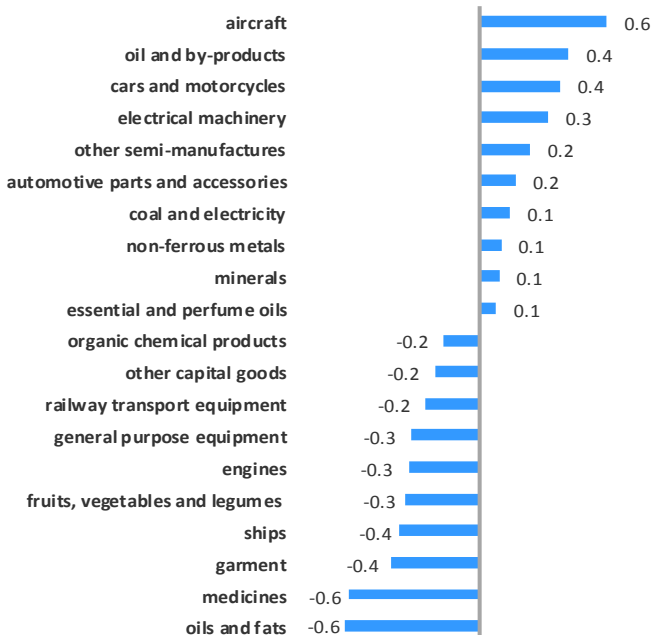
Spain's **main exporting sectors** in March 2018 were *capital goods* (representing 19.9% of total exports and diminishing by 3.8% year-on-year), *vehicles* (18.7% of total, rising by 3.0%), *food, beverages and tobacco* (15.9% of total, declining by 6.8%) and *chemical products* (13.4% of total, falling by 6.2%).



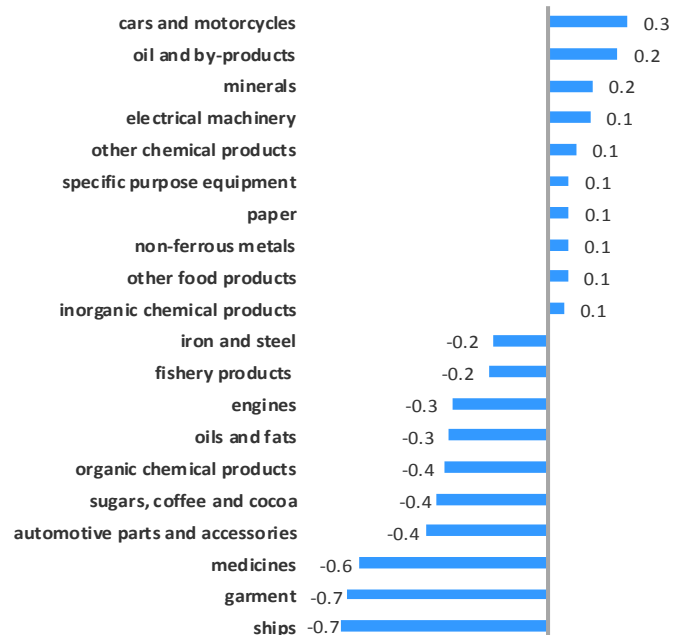
The most significant sectors of Spain's imports were *capital goods* (representing 21.5% of total imports and shrinking by 5.2% year-on-year), *chemical products* (15.2% of total, diminishing by 7.9%), *vehicles* (14.5% of total, declining by 1.0%) and *energy* (13.2% of total, expanding by 0.4%).

Among subsectors, the largest contributions to the annual change in Spain's exports in March 2018 (down by -2.4%) came from *aircraft* (0.6 points), *oil and by-products* (0.4 points) and *cars and motorcycles* (0.4 points). The major negative contributions corresponded to *oils and fats* (-0.6 points), *medicines* (-0.6 points) and *garment* (-0.4 points).

Exports (top/bottom contrib. to annual change, p.p.)



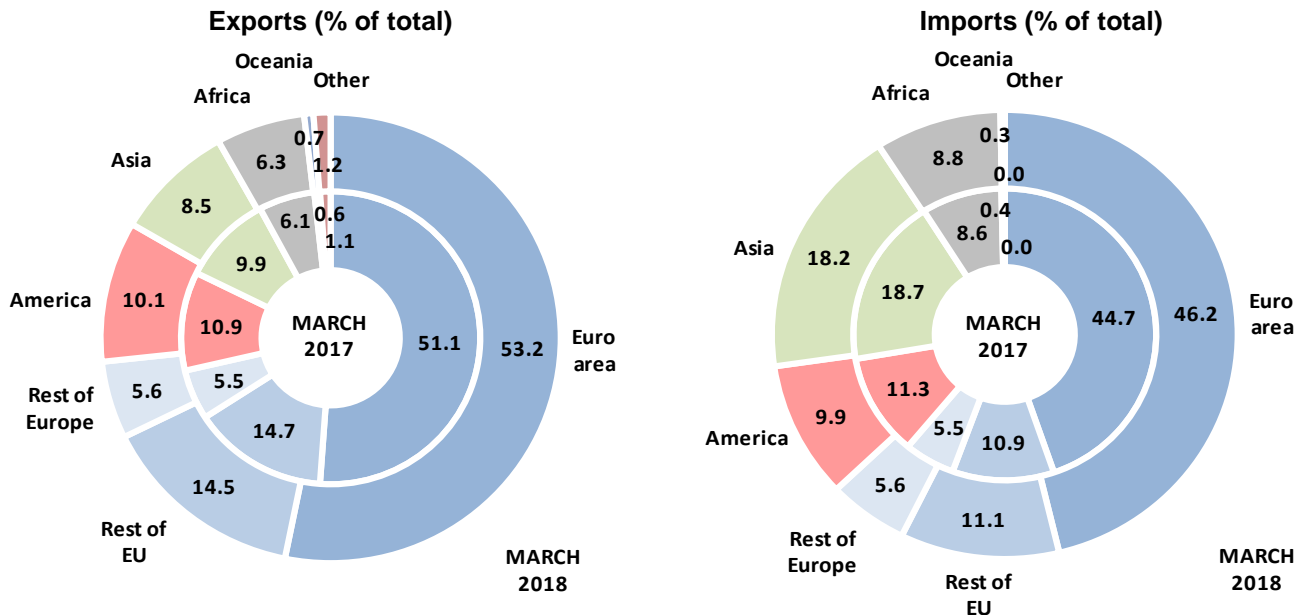
Imports (top/bottom contrib. to annual change, p.p.)



The subsectors with the most positive contribution to the annual change in Spain's imports in March 2018 (up by -4.5%) were *cars and motorcycles* (0.3 points), *oil and by-products* (0.2 points) and *minerals* (0.2 points). The major negative contributions corresponded to *ships* (-0.7 points), *garment* (-0.7 points) and *medicines* (-0.6 points).

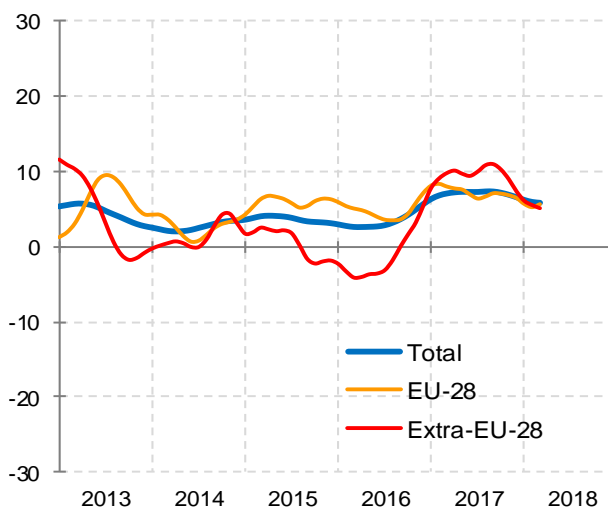
Geographic data

Exports to the **European Union** accounted for 67.7% of total exports in March 2018 (up from 65.9% in March 2017) and grew by 0.4% year-on-year. Exports to the **euro area** ran at 53.2% (up from 51.1% in March 2017) and increased by 1.5%. Exports to **non-EU countries** represented 32.3% of total exports (down from 34.1% in March 2017) as they diminished by 7.7% year-on-year.

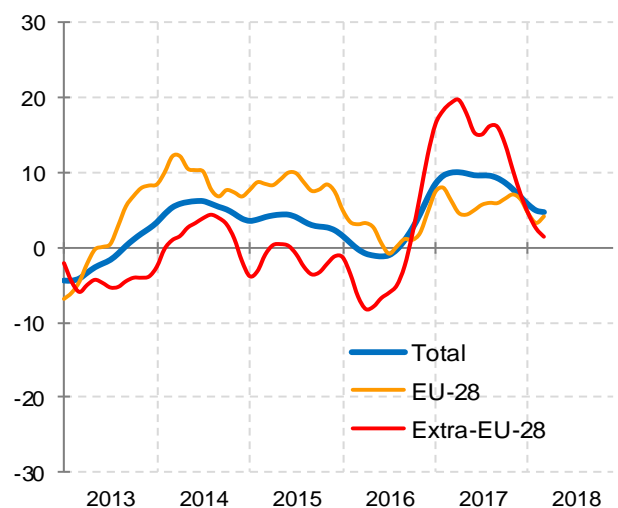


Imports from the **European Union** amounted to 57.3% of total imports in March 2018 (up from 55.6% in March 2017) and declined by 1.6% year-on-year. Imports from the **euro area** represented 46.2% (up from 44.7% in March 2017) and fell by 1.3%. Imports from **non-EU countries** accounted for 42.7% of total imports in March 2018 (down from 44.4% in March 2017) as they shrank by 8.2% year-on-year.

Exports EU and extra-EU (% y-o-y trend-cycle)



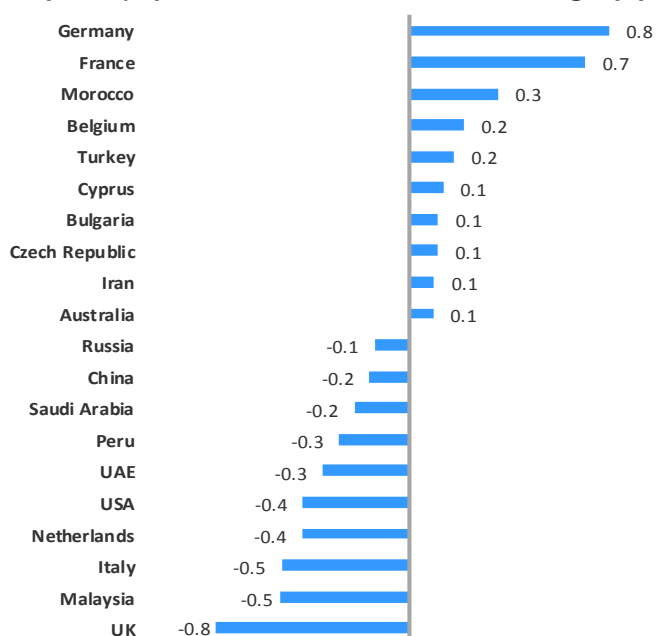
Imports EU and extra-EU (% y-o-y trend-cycle)



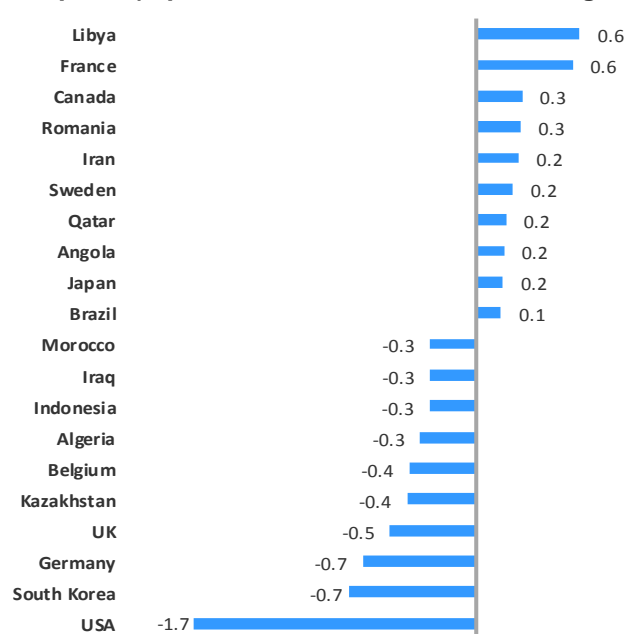
Trade balance with the European Union showed in March 2018 a surplus of 2,199.2 million euros (up from a surplus of 1,881.1 million in March 2017) and a surplus of 1,396.5 million euros with the euro area (1,028.5 million surplus in March 2017). **Trade deficit with the rest of the world** decreased to 3,029.9 million euros (from a deficit of 3,339.6 million euros in March 2017).

The **destinations with the largest contributions** to the annual change in Spain's **exports** in March 2018 (down by 2.4%) were Germany (0.8 percentage points), France (0.7 points), Morocco (0.3 points) and Belgium (0.2 points). Those destinations with the largest negative contributions were the United Kingdom (-0.8 points), Malaysia (-0.5 points), Italy (-0.5 points) and the Netherlands (-0.4 points).

Regarding **imports**, the **countries with the largest contributions** to the annual change in Spain's **imports** in March 2018 (down by 4.5%) were Libya (0.6 percentage points), France (0.6 points), Canada (0.3 points) and Romania (0.3 points). The destinations with the largest negative contributions were the United States (-1.7 points), South Korea (-0.7 points), Germany (-0.7 points) and the United Kingdom (-0.5 points).

International data

In comparison to other geographical areas, Spain's exports of goods diminished by 2.4% year-on-year in March, a higher decrease than those of the euro area (-1.8%) and the European Union (-2.0%). Within the European Union, exports also fell in Germany (-1.8%), France (-0.3%) and Italy (-1.8%), whereas those of the United Kingdom increased (1.5%). Outside the European Union, the United States exports advanced by 9.9% and Japan's by 2.1%, while those of China decreased by 3.6%.

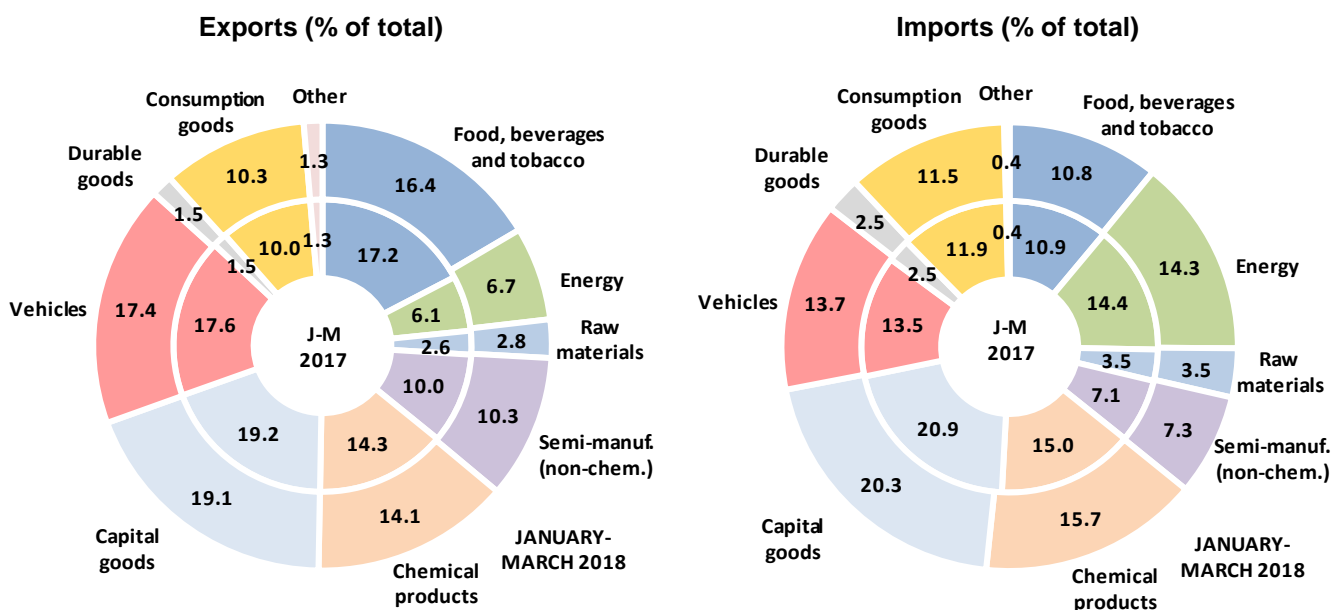
JANUARY – MARCH 2018

Spain's exports augmented by 1.8% in the period of January-March 2018 compared to the same period of 2017 to 71,024.7 million euros, and imports increased by 1.3% year-on-year to 77,958.0 million euros. In real terms, exports shrank by 0.4% year-on-year, as export prices grew by 2.2%, while imports expanded by 0.4% year-on-year, as import prices advanced by 0.9%.

Spain's trade deficit decreased to 6,933.4 million euros compared to the same period of 2017 (deficit of 7,199.3 million euros). The export/import **coverage ratio** reached 91.1%, 0.5 percentage points higher than in the same period of 2017 (90.6%, provisional data). The **non-energy trade balance** reached a deficit of 551.0 million euros, compared to a deficit of 411.3 million euros in January-March 2017, and the **energy trade deficit** expanded by 6.0% year-on-year to 6,382.4 million euros.

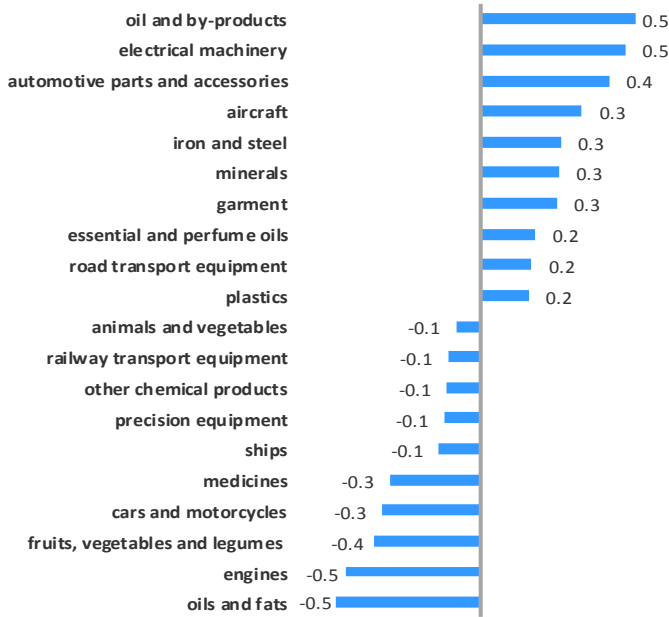
Spain's **main exporting sectors** in the period of January-March were *capital goods* (representing 19.1% of total exports, advancing by 1.5% year-on-year), *vehicles* (17.4% of total, growing by 0.6%), *food, beverages and tobacco* (16.4% of total, dropping by 3.2%) and *chemical products* (14.1% of total, rising by 0.4%).



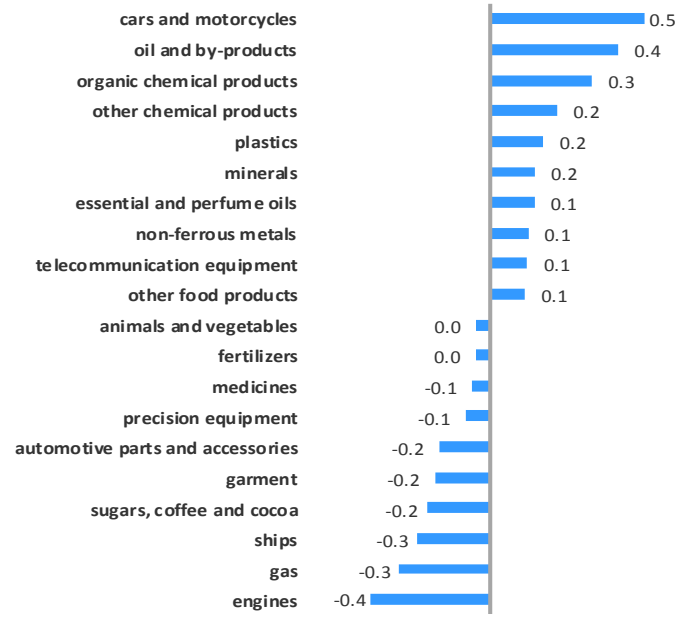
The **largest shares by sector of Spain's imports** were those of *capital goods* (representing 20.3% of total and falling by 1.6% year-on-year), *chemical products* (15.7% of total imports, increasing by 6.2%), *energy* (14.3% of total imports, expanding by 1.0%) and *vehicles* (13.7% of total imports, rising by 2.6%).

Among **subsectors**, the largest contributions to the annual change in Spain's **exports** (up by 1.8%) were *oil and by-products* (0.5 percentage points), *electrical machinery* (0.5 points) and *automotive parts and accessories* (0.4 points). On the other hand, the major negative contributions by subsectors corresponded to *oils and fats* (-0.5 points), *engines* (-0.5 points) and *fruits, vegetables and legumes* (-0.4 points).

Exports (top/bottom contrib. to annual change, p.p.)



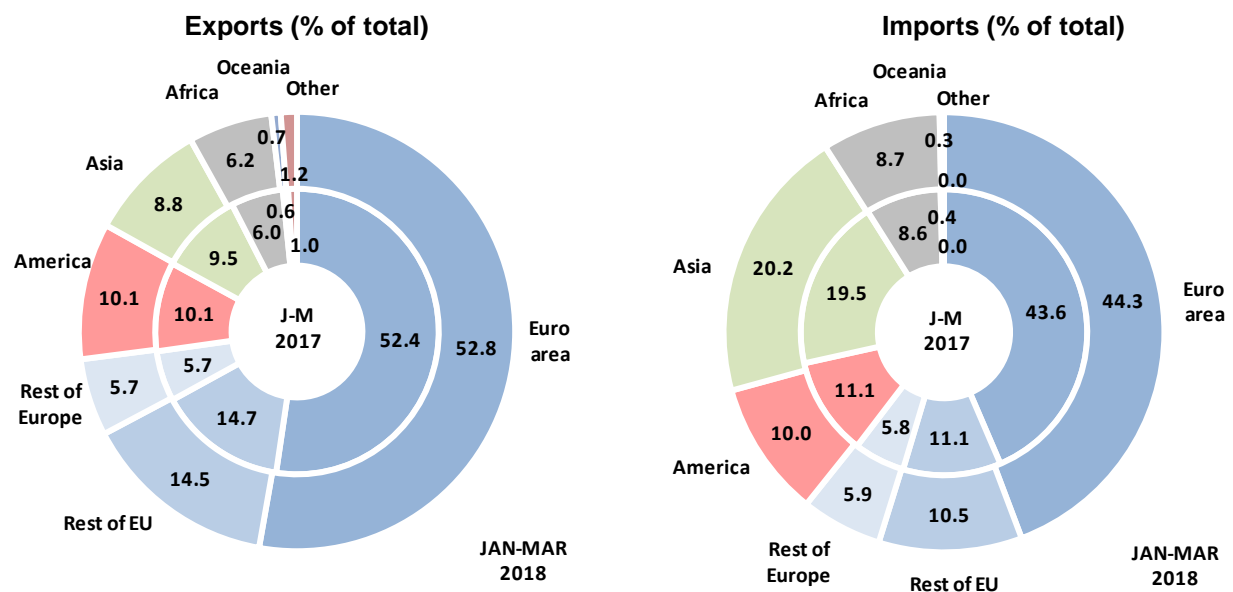
Imports (top/bottom contrib. to annual change, p.p.)



The **subsectors with the most positive contributions** to the annual change in Spain's imports in January-March 2018 (up by 1.3%) were *cars and motorcycles* (0.5 points), *oil and by-products* (0.4 points) and *organic chemical products* (0.3 points). The major negative contributions corresponded to *engines* (-0.4 points), *gas* (-0.3 points) and *ships* (-0.3 points).

Geographic data

Exports to the **European Union** represented 67.3% of total exports in the period (up from 67.1% in the same period of 2017) and augmented by 2.2% year-on-year, and exports to the **euro area** ran at 52.8% of total (52.4% in the same period of 2017) and increased by 2.7%. Exports to the **rest of the world** amounted to 32.7% of total exports (32.9% in the same period of 2017) and expanded by 1.2% year-on-year.



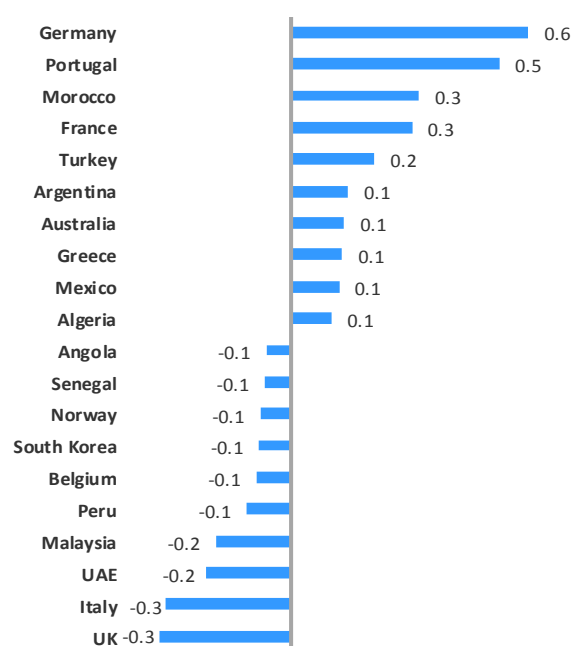
Imports from the **European Union** accounted for 54.8% of total imports in January-March 2018 (up from 54.6% in the same period of 2017) and advanced by 1.6% year-on-year. Imports from the **euro area**

amounted to 44.3% (43.6% in the same period of 2017) and grew by 3.0%. Imports from the **rest of the world** ran at 45.2% of total imports (45.4% in the same period of 2017) and went up by 0.9% year-on-year.

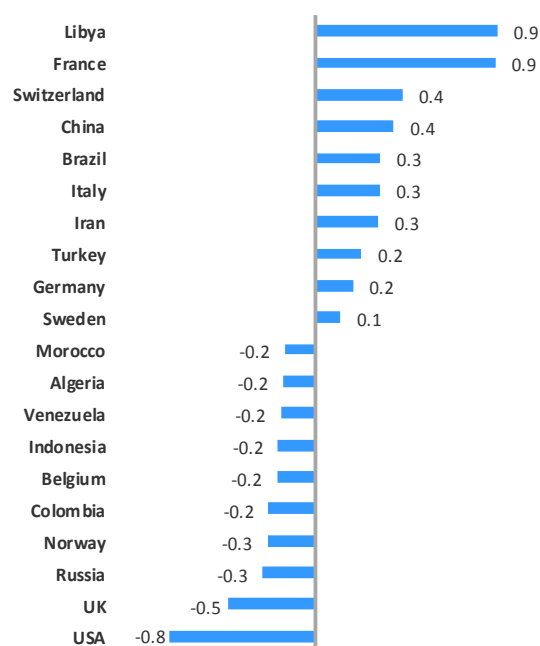
Spain's trade surplus with the European Union and with the euro area reached 5,072.4 million euros and 2,982.4 million euros respectively, up from a surplus of 4,745.9 million and down from a surplus of 3,003.7 million euros in the same period of the previous year. The **trade deficit with the rest of the world** advanced by 0.5% year-on-year to 12,005.8 million euros.

In terms of **contribution to the annual change of exports** (up by 1.8%), the main contributions were those of Germany (0.6 percentage points), Portugal (0.5 points), Morocco (0.3 points) and France (0.3 points). Those destinations with the largest negative contributions were the United Kingdom (-0.3 points), Italy (-0.3 points), the United Arab Emirates (-0.2 points) and Malaysia (-0.2 points).

Imports (top/bottom contrib. to annual change, p.p.)



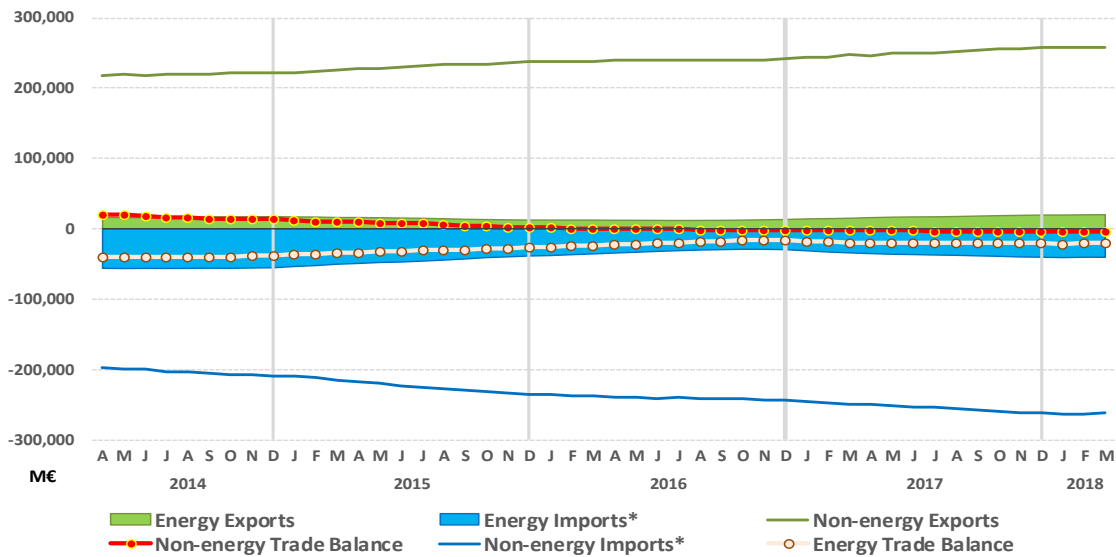
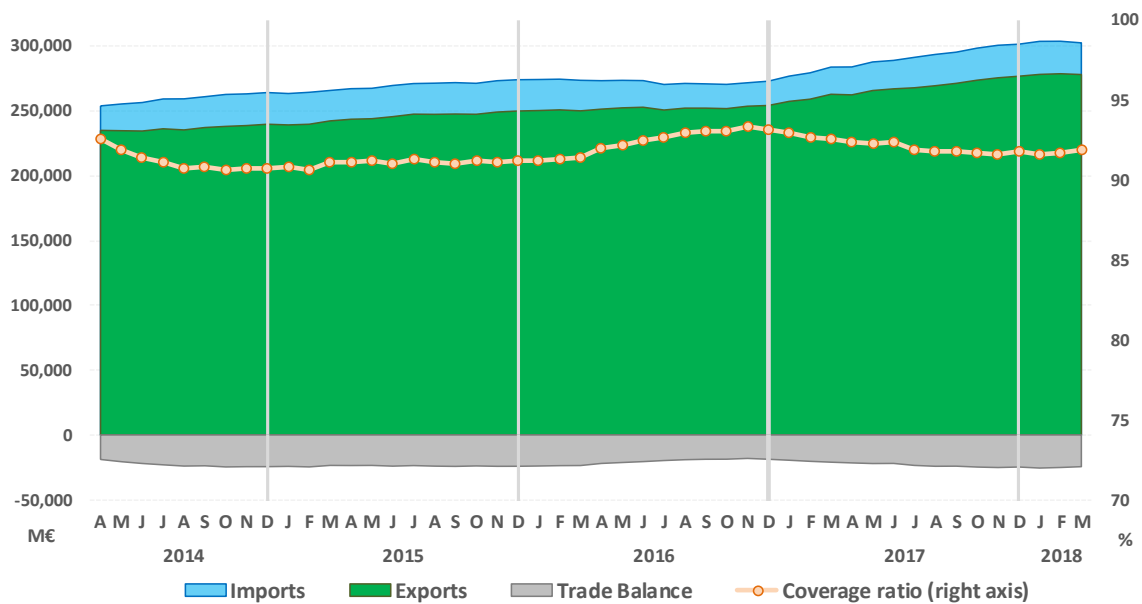
Regarding **imports**, the **countries with the largest contribution** to the annual change in Spain's **imports** in the period (up by 1.3%) were Libya (0.9 percentage points), France (0.9 points), Switzerland (0.4 points) and China (0.4 points). The destinations with the largest negative contributions were the United States (-0.8 points), the United Kingdom (-0.5 points), Russia (-0.3 points) and Norway (-0.3 points).

In the period January-March, the number of **Spanish exporters** rose by 21.0% year-on-year to 93,060 exporters, out of which 24,959 had already exported at least 50,000 euros worth of goods in the period, 1.0% less than in the same period of 2017. With regard to regular exporters (those that have already exported in the current year as well as in each of the three preceding years), they amounted to 42,883 in the period, 46.1% of total exporters and 0.9% more than in the same period of 2017. Their exports reached 68,326.7 million, 96.2% of total exports and 2.3% more than in the same period of the previous year.

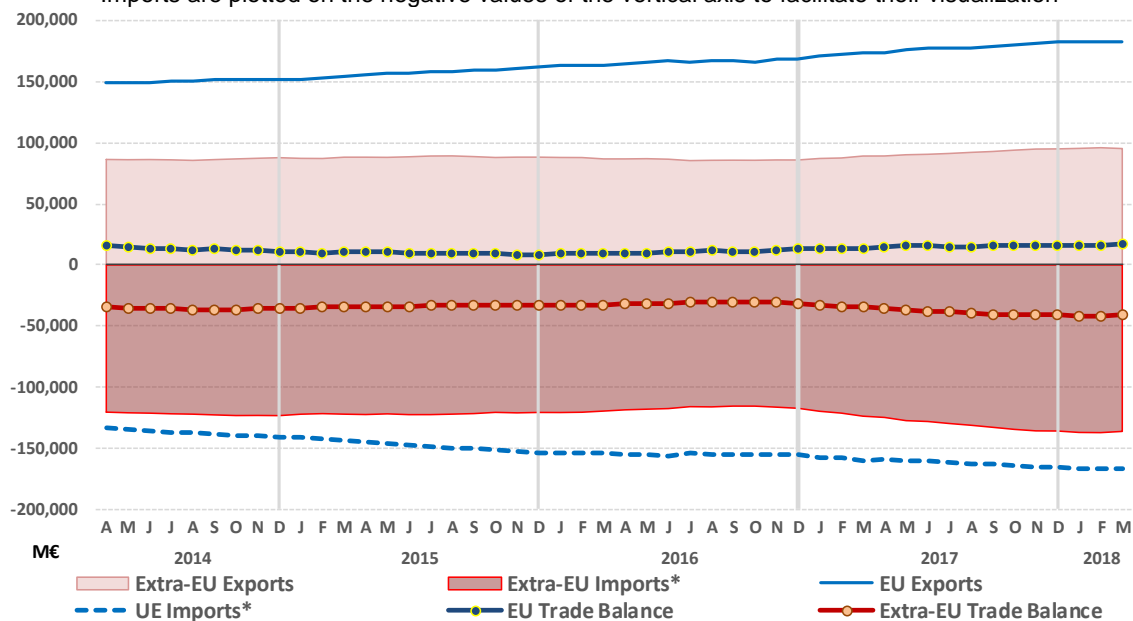
International data

In comparison to other geographical areas, Spain's exports of goods augmented by 1.8% year-on-year in the period of January-March 2018, a lower rate than those attained by the euro area (3.3%) and the European Union (2.9%). Within the European Union, exports also increased in Germany (2.8%), France (3.9%), Italy (3.3%) and the United Kingdom (2.0%). Outside the European Union, the United States exports advanced by 7.9% year-on-year, China's by 13.0% and Japan's by 4.9%
