


HOUSING INVESTMENT AND COMPOSITE INDICATOR y-o-y % change



CEMENT CONSUMPTION AND CIP| BUILDING y-o-y % change




ORDER BOOKS & CONSTRUCTION CONFIDENCE balances in pp



HOUSING FLOORAGE APPROVALS & IPI CLAY BUILDING y-o-y % change (smoothed)




CREDIT FOR HOUSE PURCHASE & MORTGAGES y-o-y % change
