
**HOUSING INVESTMENT AND COMPOSITE INDICATOR**  
y-o-y % change








**HOUSE FLOORAGE APPROVALS & CIPi BUILDING**


**CREDIT FOR HOUSE PURCHASE & MORTGAGES**
