




JULY 2016

In July 2016, **Spain's exports decreased by 9.1%** year-on-year in nominal terms to 21,366.4 million euros, whereas **imports fell by 12.0%** to 21,924.2 million euros. With seasonally adjusted data, exports declined by 3.6% year-on-year and imports by 6.1%. In **real terms**, exports declined by 7.6% year-on-year, as export prices fell by 1.7%, and imports decreased by 9.0%, as import prices shrank by 3.3%. In nominal terms on a **month-on-month** basis, exports diminished by 5.8% and imports by 8.8%. With seasonally adjusted data, exports decreased by 1.0% month-on-month and imports by 1.9%.






Spain's **trade balance** registered a deficit of 557.8 million euros, down from a deficit of 1,396.1 million euros in July 2015 (provisional data). The export/import **coverage ratio** reached 97.5%, 3.1 percentage points higher than in the same month of 2015 (94.4% in July 2015 with provisional data). The **non-energy trade balance** reached a surplus of 914.3 million euros, similar to the surplus attained in the same month of 2015 (933.1 million). The **energy trade deficit** fell by 36.8% year-on-year to 1,472.1 million euros, compared to a deficit of 2,329.2 million euros in July 2015.




Sectoral data

Spain's **main exporting sectors** in July 2016 were *capital goods* (representing 21.0% of total exports and dropping by 5.1% year-on-year), *vehicles* (17.5% of total, decreasing by 9.6%), *food, beverages and tobacco* (16.0% of total, shrinking by 2.9%) and *chemical products* (14.7% of total, falling by 8.9%).



The **most significant sectors of Spain's imports** were *capital goods* (representing 22.1% of total imports and falling by 2.5% year-on-year), *chemical products* (16.2% of total, falling by 16.5%), *consumption goods* (12.9% of total, decreasing by 7.5%), and *vehicles* (12.1% of total, dropping by 13.1%).


Among **subsectors**, **the largest positive contributions** to the annual change in Spain's **exports** in July 2016 (down by 9.1%) came from *other chemical products* (0.3 percentage points), *meat products* (0.2 points) and *ships* (0.2 points). On the contrary, the major negative contributions corresponded to *cars and motorcycles* (-1.4 points), *minerals* (-0.7 points) and *medicines* (-0.6 points).




The **subsectors with the most positive contribution** to the annual change in Spain's **imports** in July 2016 (down by 12.0%) were *aircraft* (0.3 points), *fishery products* (0.1 points) and *ships* (0.1 points). The major negative contributions corresponded to *oil and by-products* (-3.2 points), *minerals* (-1.2 points) and *automotive parts and accessories* (-1.1 points).

Geographic data

Exports to the **European Union** accounted for 65.3% of total exports in July 2016 (up from 63.6% in July 2015) and decreased by 6.7% year-on-year. Exports to the **euro area** accounted for 50.2% (up from 49.3% in July 2015) and shrank by 7.5%. Exports to **non-EU countries** accounted for 34.7% of total exports (down from 36.4% in July 2015) as they declined by 13.4% year-on-year.




Imports from the **European Union** accounted for 56.7% of total imports in July 2016 (up from 55.6% in July 2015) and decreased by 10.2% year-on-year. Imports from the **euro area** represented 45.5% (up from 44.3% in July 2015) and decreased by 9.6%. Imports from **non-EU countries** accounted for 43.3% of total imports in July 2016 (down from 44.4% in July 2015) as they decreased by 14.1% year-on-year.



Trade balance with the European Union showed in July 2016 a surplus of 1,528.5 million euros (up from 1,108.0 million surplus in July 2015) and a surplus of 740.1 million euros with the euro area (up from 553.1 million surplus in July 2015). **Trade deficit with the rest of the world** decreased to 2,086.3 million euros (from a deficit of 2,504.1 million euros in July 2015).

The **destinations with the largest contributions** to the annual change in Spain's **exports** in July 2016 (down by 9.1%) were the United Kingdom (0.7 percentage points), Italy (0.4 points), Canada (0.3 points) and Belgium (0.3 points). Those destinations with the largest negative contributions were France (-2.9 points), the United States (-1.2 points), Germany (-1.0 points) and Bulgaria (-0.7 points).



Regarding **imports**, the **countries with the largest contributions** to the annual change in Spain's **imports** in July 2016 (down by 12.0%) were Russia (0.4 percentage points), Iran (0.3 points), Azerbaijan (0.3 points) and Iraq (0.2 points). The destinations with the largest negative contributions were Germany (-1.8 points), the United States (-1.3 points), the United Kingdom (-1.0 points) and Algeria (-0.9 points).

International data

In comparison to other geographical areas, Spain's exports of goods declined by 9.1% year-on-year in July, in line with the decreases shown in the euro area (-8.5%) and the European Union (-9.0%). Within the European Union, exports also fell in Germany (-10.0%), France (-9.1%), Italy (-7.3%) and in the United Kingdom (-3.3%). Outside the European Union, the United States exports decreased by 6.5%, China's by 5.3% and Japan's by 14.0%.


JANUARY – JULY 2016

Spain's exports advanced by 0.5% in the period of January-July 2016 compared to the same period of 2015 to 149,407.6 million euros, whereas imports declined by 2.3% year-on-year to 157,843.7 million euros. In real terms, exports grew by 2.9% year-on-year, as export prices fell by 2.3%, and imports rose by 2.5% year-on-year, as import prices declined by 4.7%.

Spain's trade deficit decreased to 8,436.1 million euros compared to the same period of 2015 (deficit of 12,876.5 million euros). The export/import **coverage ratio** reached 94.7%, 2.6 percentage points higher than in the same period of 2015 (92.0%, provisional data). The **non-energy trade balance** reached a surplus of 1,013.6 million euros, compared to a surplus of 3,493.3 million euros in January-July 2015, whereas the **energy trade deficit** declined by 42.3% year-on-year to 9,449.8 million euros.


Sectoral data

Spain's **main exporting sectors** in the period of January-July were *capital goods* (representing 20.3% of total exports, growing by 3.6% year-on-year), *vehicles* (18.7% of total, rising by 9.6%), *food, beverages and tobacco* (16.9% of total, increasing by 5.0%) and *chemical products* (14.4% of total, declining by 1.6%).



The **largest shares by sector of Spain's imports** were those of *capital goods* (representing 21.8% of total and increasing by 7.7% year-on-year), *chemical products* (16.2% of total imports, falling by 2.5%), *vehicles* (14.4% of total imports, advancing by 4.2%) and *consumption goods* (12.5% of total imports, rising by 6.0%).


Among **subsectors**, the largest contributions to the annual change in Spain's **exports** (up by 0.5%) were cars and motorcycles (1.4 percentage points), road transport equipment (0.6 points) and garment (0.3 points). On the other hand, the major negative contributions by subsectors corresponded to *iron and steel* (-0.5 points), minerals (-0.3 points) and medicines (-0.3 points).



The **subsectors with most positive contributions** to the annual change in Spain's **imports** in January-July 2016 (down by 2.3%) were *cars and motorcycles* (0.8 points), *garment* (0.4 points) and *aircraft* (0.4 points). The major negative contributions corresponded to *oil and by-products* (-3.6 points), *gas* (-0.7 points) and *minerals* (-0.6 points).

Geographic data

Exports to the **European Union** accounted for 66.7% of total exports in the period (up from 64.6% in the same period of 2015) and grew by 3.7% year-on-year, while exports to the **euro area** accounted for 51.9% of total (50.5% in the same period of 2015) and expanded by 3.2%. Exports to the **rest of the world** accounted for 33.3% of total exports (35.4% in the same period of 2015) and diminished by 5.4% year-on-year.




Imports from the **European Union** accounted for 57.6% of total imports in January-July 2016 (up from 55.7% in the same period of 2015) and increased by 1.2% year-on-year. Imports from the **euro area** accounted for 46.2% (44.5% in the same period of 2015) and grew by 1.4%. Imports from the **rest of the**

world accounted for 42.4% of total imports (44.3% in the same period of 2015) and fell by 6.6% year-on-year.

Spain's trade surplus with the European Union and with the euro area increased to 8,595.8 million euros and to 4,523.2 million euros respectively, up from surpluses of 6,059.9 million and 3,138.9 million euros in the same period of the previous year. The trade deficit with the rest of the world decreased by 10.1% year-on-year to 17,032.0 million euros.

In terms of **contribution to the annual change of exports** (up by 0.5%), the main contributions were those of the United Kingdom (0.8 percentage points), Germany (0.6 points), Italy (0.6 points) and Belgium (0.5 points). Those destinations with the largest negative contributions were France (-0.4 points), Saudi Arabia (-0.4 points), Gibraltar (-0.3 points) and Brazil (-0.2 points).




Regarding **imports**, the **countries with the largest contribution** to the annual change in Spain's **imports** in the period (down by 2.3%) were Germany (0.3 percentage points), Morocco (0.3 points), Italy (0.3 points) and Iran (0.2 points). The destinations with the largest negative contributions were Algeria (-0.8 points), Angola (-0.5 points), Nigeria (-0.4 points) and Colombia (-0.3 points).

In the period January-July, the number of **Spanish exporters** grew by 1.0% year-on-year to 112,022 exporters, out of which 32,293 had already exported at least 50,000 euros worth of goods in the period, 0.3% less than in the same period of 2015. With regard to regular exporters (those that have already exported in the current year as well as in each of the three preceding years), they amounted to 47,205 in the period, 42.1% of total exporters and 4.2% more than in the same period of 2015. Their exports reached 141,778.9 million, 94.9% of total exports and 1.7% more than in the same period of the previous year.

International data

In comparison to other geographical areas, Spain's exports of goods advanced by 0.5% year-on-year in the period of January-July 2016, in contrast to the decreases recorded by the euro area (-1.4%) and the European Union (-2.0%). Within the European Union, exports also fell in Germany (-0.3%), France (-2.2%), Italy (-1.2%) and the United Kingdom (-5.0%). Outside the European Union, the United States exports decreased by 6.4%, China's by 6.7% and Japan's by 9.5%
